**Proposed Action:** FY' 14 Adjusted Budget Corrections for LSNA project grants as follows: OWEB 212-3999-9837 – reduce Contracted Services allocation for Feb 2014 by \$3635.30

### **Changes at OWEB** - Update

Council Support Eligibility Criteria – See attached checklist from OWEB describing policies, bylaws, organizational structure and other requirements by OWEB for grantees. Among actions needed to comply: Update action plan (approval needed for Part. 1); Bylaws need language concerning litigation; board membership policies need to describe interests; bylaws need to include fiscal policy; policies need to include non-discrimination language; mission needs to be rewritten to OWEB standards; membership levels, responsibilities and powers need to be clearly stated, along with term limits. Deadline to complete changes is November 2014 to January 2015.

Focused Investments/Special Investment Partnership (SIP) – OWEB is in the process of redefining SIP. LWC will have to reapply to be a SIP partner, on a competitive basis. Current funding through 2015 is secured, but future funding for the Model Watershed and LSNA is at risk. This means commitments made to landowners beyond 2015 could be unsecured. Meetings with a facilitator will take place later this year. RFPs to propose SIP projects by the LWC will out July through October.

#### **Steering Committee Report**

Watershed Council Boundaries – Action

Proposed action (modifies LWC by-laws): To modify the Geographic Area of the

Luckiamute Watershed Council as defined by the attached map. See attached map. The changes would add 2,000 to 3,000 acres to the watershed in the Willamette River area near Springhill Road. The Luckiamute Watershed Council is already conducting projects in this area. *ACTION* – Kelly Gordon moved and Steve deGoey seconded a motion to change the bylaws to include the area indicated in the map. The change fills in the area between the Luckiamute River watershed and the Willamette River at the Luckiamute State Natural Area along Spring Hill Road to Spring Hill. *MOTION APPROVED*.

Establishing a PayPal donation button on LWC web site - Update Gail
Gail is researching the idea to create a button on the Luckiamute Watershed Council's website that links to a Paypal account. This would allow website users to purchase donated items such as t-shirts, or make direct contributions to the Luckiamute Watershed Council. A separate savings account, with similar signers as the regular account, would be established at our bank, for unencumbered funds raised this way. We have checked with the bank to be sure this is possible. We need to also check with Cascade Pacific RCD to establish management and reporting requirements. Gail will bring a proposal to the March

The finance committee is looking at fiscal management costs and hopes to create an RFP to release to potential fiscal managers. Among considerations: The fiscal year ends in June. This, or the end of the quarter would be a good time to begin fiscal management contracts. The current contract with CPRC&D ends in June. The finance committee and steering committee will bring specific numbers for the RFP to the council meeting in March.
