#### <u>Mission Moment & Questions / Comments on Committee Minutes / Activities</u> Board and Committee Members

Discussion on the February 27 EC minutes, third bullet under the OWEB 219-2021 Council Capacity Work Plan – Wendy asked for clarification around the need for defining "criteria" to join the Board or a committee. Pat has been talking to community members and people don't feel "qualified" to join; LWC can help this by summarizing what we're looking for and that people don't need specific experiences to join. Noted as a job for the Governance Committee. Discussion on the March 6, 2019 Fundraising Committee minutes – how does the Board feel about soliciting and / or accepting donations from Cannabis operations in our watershed? Are we okay with this? Are we worried that our constituents will be upset? General sense that these operations are now legal in Oregon and are essentially another farming and / or processing operation. We don't police the practices of our other donors, why should this be different? It can open a conversation of how the operations can be more sustainable – conserve water, protect soil, etc.

## **<u>2018 Temperature Monitoring Presentation</u>** *Caleb Price, Monitoring Coord.*

Caleb provided a summary of the LWC monitoring program and data from 2018. Feedback and questions welcomed. Volunteers for field deployment trips also welcomed. Next presentation, March 21 for the public at the Monmouth Public Library.

## Offer of Donated Property on Ash Creek – Updates on information gathering

Pat is gathering information and working on a report for the Board. There are many issues to consider including zoning, interests of the City of Independence and neighbors, history of the site and potential for environmental contamination, liabilities, and access. Discussion that the Board can take some time to continue to do research and consider how to manage this offer and generate a benefit out of it if possible while managing risk. Some are concerned that there is little or no benefit to be derived and too much risk. Others feel the LWC can navigate the risks and potentially protect the property and / or generate revenue.
