## Steering Committee Report

#### Fiscal Services Transition – Action

Proposed Action: Approve Fiscal Sponsorship Agreement, effective July 1, 2014

Discussion: In the details of the contract, there was discussion on the matter of Mary's River approving our budget and other requirements listed, as is required by their bylaws. Is the contract overly-prescriptive? The contract upholds IRS rules for non-profits. They have consulted an attorney. A document that includes a scope of work would be separate as fiscal sponsorship and fiscal management services are distinct. But we want to include a clear scope of service. There are clauses for termination and to modify terms and arrangements. What could go wrong? They could want more money than they want now. Transition could be rocky. Our failure to comply could result in Mary's River suing for violation of the agreement. Dan moved, Steve seconded the motion to approve the fiscal agreement. **MOTION APPROVED**.

## OWEB Building capacity grant - Action Item

Proposed Action: Approve submission of OWEB Technical Assistance Building Capacity Grant Pre-proposal in partnership with the MRWC

Discussion: The pre-proposal is due July 1. Plans are to apply with MRWC for the grant. Interviews with OWEB are Aug. 4-6. The grant will support a joint retreat with facilitator, consultant, review of 501c3, collaboration, a second retreat, legal consultation, travel and more. Also other partners include SWCD, Green Belt, and others. The amount is to be announced. The goal of the project sponsored by the grant is to look for opportunities to share staff, collaborate and possibly, merger. **MOTION APPROVED**.

<u>Projects Update</u>

See full report in board packet. Summary: Maintenance project is just finished up at LSNA. Contractors have treated yellow flag iris in the Model Watershed right of way. Reemerging weeds have been treated. J-P met with Melendys to discuss Ash Creek project, also Coopers and the Penas. Also continuing is knotweed planning with landowners concerned about certified organic regulations.

Bush update – Our contractor treated his site and accidentally sprayed his hops (Diego). A follow-up is to come. Damages would be assessed on Diego. J-P went and took photos of the patch, assessed the damage. Bush is disappointed, and J-P has apologized. If hops were damaged, would know in three weeks – we're at 2 weeks now. There are \$20,000 worth of reveg plants in the ground that need protected.
